

Bruno's Jet Ski Rentals - Rental Agreement

This Rental Agreement (hereinafter referred to as "Agreement") is made on _____, by and between BRUNO'S JET SKI RENTALS (hereinafter "BJSR" and _____ (hereinafter "client"). Client hereby acknowledges and agrees to the following terms with respect to the rental(s) of

The Subject matter of this Agreement are hereinafter referred to as "Vessels".

SECURITY RESERVE/HOLD: Client hereby authorizes BJSR to place a security reserve/hold of **\$350 PER JET SKI and/or \$500 PER BOAT on a major credit card** (or to retain amount in cash) against any outstanding charges, including, but not limited to damage to engine or pump, lost or damaged items, late returns, excessively unclean Vessel(s), or damage to the Vessel(s) resulting from negligent operation or activity on the Vessel(s) during the rental period or against any liability that Client or Client's guests may incur to Owner. Damage to or loss of the equipment or of any of its contents can be well in excess of the security amount reserved, up to and including the replacement cost of the equipment. **The security reserve is held until the Vessel(s) have been inspected.** If there is no damage to the Vessel(s) or its' contents the full amount of the security reserve will be released within 24 hours. BJSR will not be responsible for delays in customer bank refunds. Checks will not be accepted for this fee.

AGE RESTRICTION: The Client making the reservation must be at least 18 years of age, hold a valid driver's license, and a valid Visa, MasterCard, Discover or American Express credit card. The Client and Driver(s) of the Vessel(s) born on or after September 1, 1993 who wishes to operate certain vessels on the public waterways of Texas **MUST** take a Boater Education Certification Course BJSR requires anyone wishing to operate the Sun Tracker- Pontoon Boat must be over the age of 25 to operate the Vessel(s).

PAYMENT: A \$200 deposit is required on a Major Credit or Check Card and is due in order to secure Client's reservation for hourly and/or daily rentals. This deposit will be applied toward Client's total charges. The balance of the client's rental fees, including taxes, is due in full at the end of the reservation period at which time BJSR picks up the Vessel(s) and must be paid by cash, major credit card or debit card. Person Check's will not be accepted for the deposit or for payment on final balances. Payment for same day rentals are due at the time the reservation is made over the phone or in person.

CANCELLATION: A Minimum of **48 hours' notice** is required for any cancellation of a reserved rental period. Cancellation made 3 less than the described minimum will result in the reservation deposit being forfeited.

LATE FEE: Late returns shall result in a \$25 fee for each 15 minutes that the Client is late to the pick-up location.

ADDITIONAL TERMS/ REQUIREMENTS/PROHIBITIONS:

-Client will be responsible for anchoring Vessel(s) at least 10 feet from the shore or dock and from any surrounding water crafts, structures and land when not in use.

-Vessel(s) are subject to availability due to unforeseen damage or repair beyond Clients control.

-Client is prohibited from taking or allowing Vessel(s) to be taken upon land of any kind.

-Client is responsible for any damage or loss to the Vessel(s) and/or their contents during rental period.

-Client is subject to automatic forfeiture of security hold if Clients violates any terms or conditions of this rental agreement.

-Client will be responsible for loss of future rental income should the Vessel(s) become disabled as a result of damage cause by the Client's failure to comply with any/all terms and conditions of this rental agreement. (Minimum rental fee a day)

STANDARD LAW/BASIC SAFETY REQUIREMENTS: Client hereby agrees to comply with all federal, state and local laws and ordinance applicable to the use of the Vessel(s). Client further acknowledges and agrees that there is to be no alcoholic consumption on the Vessel(s) by anyone under the age of 21 or by designated driver of the Vessel(s). If designated driver is other than the Client, BJSR must be provided with their name, age address and a copy of their driver's license at the time of reservation or prior to departure. Client further acknowledges that he/she is familiar with the safe operation of watercraft, including the jet ski(s) and Pontoon boat being rented.
